Secretary (Coord), 4<sup>th</sup> floor, Cabinet block, Islamabad. A separate bid should be given for each vehicle.
4. Bid (s) shall accompany a pay order/bank draft for an amount equivalent to 10% of the bid price in the name of DDO, Ministry of Information Broadcasting & National Heritage as bid security alongwith the copy of the NIC/CNIC/NICOP/Smart Card issued by NADRA.
5. GST/Income Tax (if admissible) shall be as per prevailing law.
6. The Ministry reserves the right to accept or reject any or all bids and to withdraw any number of vehicles from the auction before or after the submission/opening of bids without assigning any reason or advance notice.
